Observations on Greek Feminine Names Attested in Macedonia

Although the Macedonian onomasticon has been repeatedly discussed as a source of interpreting the language of ancient Macedonians¹ it has not yet been approached in the way F. Bechtel has instituted². Only the names of Thessalonike gave the ground for an examination of its names by categories formed mostly on the basis of the meaning of the words by which they were formed³; this examination by G. Mihailov, without being exhaustive, manifested the richness of the onomasticon of this great Macedonian city.

There are, of course, many different ways of approaching the onomasticon attested in the inscriptions found in any region. Our interest for the feminine names instead of the masculine ones was originally due to the advantages of dealing with a much more limited number of tes-

timonia and also a smaller number of names⁴, for reasons that have to do with the position of women in the ancient Greek world, in general. Observations on the basic features and special character of the names of women in Greek were recently discussed by O. Masson on the basis of F. Bechtel's classification⁵.

In our approach we excluded from the relevant material all the panhellenic names, among which the theophoric and other frequent ones are included: the majority of them are compound names by words not different from the ones used for the formation of men's names⁶. Our attention is focused in some categories of names which are not very common in general: each of these categories includes some very rare examples as is shown by the tracing of the distribution of the most interesting ones in each of the categories that we will examine.

1. Words with an abstract meaning used as personal names

This category is mostly expressed by the formation of feminine names⁷. Adjectives formed by analogous words (e. g., Πίστη, Ὑγείνη) are not included in the list that follows because they appear also as masculine names and they belong to different categories.

The name Εύπορια, the name of a city in Bisaltia, most probably does not belong to this category but to another, richly represented in the Macedonian onomasticon, that of geographical names used as anthroponyms⁵¹; also as the names of towns, although not of Macedonia, are attested the names ‘Υλη⁵² and Εύποτερία⁵³. The names Τύχη and ‘Υγεία also most probably do not belong to this category but to the names of deities adopted as anthroponyms, analogous to Ἐρμῆς⁵⁴. Excepted should probably also be the name Εύφροσύνη, as the name of one of the Charites⁵⁵; the reason for including them in the list lies in the meaning of the words from which they are derived, which certainly ties with the rest and helps to understand their presence. Names of the same category attested in monuments dated later than the end of the 3rd or the beginning of the 4th century A. D., e. g., Σοφία⁵⁶, were not included in the list.

All the names in this category are the same, without any change, as the nouns which gave the inspiration for their use as names. Most of the names listed above (a total of 42), originate from feminine nouns; the only ones which are not feminine are: Ἀξίωμα, Ἔνκώμιον,

Νόημα⁵⁷. These three neutral names — and even more the second — connect this to the next category of feminine names which we will examine later.

The names Ἀλκή, Ἄξιωμα, Ἀρετή, Δόξα, Δύναμις, Ἐλπίς, Ἐπίκτησις, Εύνοια, Εὐπορία, Εύτυχία, Ἰστορία, Μελέτη, Νόημα, Ῥητορική, Χαρά are not included in Bechtel's list of the "abstract" names⁵⁸; in other categories, in the same work, the names Εὐφροσύνη and Τύχη are listed⁵⁹. Some names from the previously mentioned group, the names Ἀλκή, Ἄξιωμα, Δόξα, Δύναμις, Ἐλπίς, Ἐπίκτησις, Νόημα, Ῥητορική, Τύχη, and Χαρά are attested in Rome along with the names Ἀνάλημψις, Εὐγένεια, Εὐπορία, Ζωή, Ἡδονή, Πίστις, Προκοπή, Πρόσδεξις, Πρόφασις, Υγεία, Υλη, and Χαρμοσύνη⁶⁰. The names Διήγησις, Ἐνκώμιον, Εὐπατρία, Εὐστοργία, Εὐωδία, Λογική, Προκρατία, Προσδοχή, and Συνγραφή are not listed in the works already mentioned and seem to be the rarer ones in this category⁶¹.

2. Neutral nouns and diminutives used as feminine names

These names end in -tov, which usually is reduced to -i(o)v; they have the meaning of diminutives and they are exclusively used as feminine names⁶²:

As it can be noticed from this list, this category includes names derived from a variety of words descriptive of the positive qualities of the named person's appearance or character as are the names Γλυκέριν, Ἐλευθέριον, Εύχάριον, Μεγέθιν, Φιλημάτιον, and Χαρίτιν; most of these names are known from elsewhere⁷⁹. Μεγέθιν and Εύχάριον I was not able to find. Diminutives of words for animals or birds, also metaphorically descriptive of the persons' characteristics occupy a substantial part of the above list: "Αρνιον, Βοΐδιον Μόσχειον, Χελειδόνιν; the first one seems to be attested only here, though a number of cognates are known⁸⁰, the others are widely attested⁸¹. Words meaning valuable material or an object that has been worked out of a precious metal inspired the creation of the names Ζμαράγδιν, Χρυσάριον and Τορευμάτιον, which belong to a category of names that became popular in the imperial period⁸². The name 'Ανπέλιν is derived from the plant from which wine is produced⁸³; its fruit βότρυς is born as an anthroponym by a Macedonian already in the 5th century B. C.⁸⁴

3. Nouns for objects used as feminine names

This category of names, rare in general, but widely attested as can be seen on the basis of F. Bechtel's basic work⁸⁵ and its attestations in Rome⁸⁶.

The name Καλύβη probably does not belong to this category, if its meaning is not derived from the word that means hut, but it is the name of a nymph⁹⁶. Ὀλπίς is probably an alteration for ὄπλή, not attested elsewhere; a similar explanation should also most probably be given to Δέλτις from δέλτος⁹⁷.

4. Participles used as feminine names

Names of this category form quite a numerous group in general; some of the names in this group are rare as is shown in a recent treatment of the subject by O. Masson⁹⁸.

The examination of the above categories of Greek feminine names attested in Macedonia indicates, I believe, the richness of the onomasticon of this region, shown not only by the creation of names with local characteristics such as Ἀδαία, Βουλομάγα, Εύρυδίκα, Ζοῖχη, Ααδόμα and many others¹⁰⁷, but also by that of new ones, in categories of panhellenic distribution; further examination of the Macedonian onomasticon will certainly illuminate more sides of its very interesting composition.
